A TEAM OF NFCR-FUNDED SCIENTISTS ARE WORKING TO FILL BOTH GAPS WITH ONE SOLUTION. THE TEAM HAS DEVELOPED A NEW SENSITIVE MOLECULAR IMAGING PROBE THAT CAN DETECT EVEN A MINUTE AMOUNT OF A MOLECULE CALLED PMSA WHICH EXISTS IN THE VASCULATURE OF LIVER CANCER. THIS MAKES EARLY DETECTION OF SMALL LIVER TUMORS POSSIBLE.
